




Dear Distributor,

I'm sure you are aware of the upcoming California Proposition 65 regulations that require all manufacturers, distributors, and retailers that sell or distribute consumer products in California to comply with the state's new warning requirements. These new regulations, implemented under California Proposition 65, (otherwise known as the California Safe Drinking Water and Toxic Enforcement Act) require warnings on products and premises that can potentially expose consumers to more than 900 specified chemicals and chemical byproducts. The new regulations go into effect on August 30, 2018.

As a manufacturer, we have many products and parts that are currently under review regarding chemical composition. Until we have determined compliance or Safe Harbor, we are labeling everything we sell in the U.S. with the California Proposition 65 Warning below:

In addition to labeling our products with the California Proposition 65 Warning, Bullard has also taken the following measures:

- Warnings can be found in user manuals, on labels, on bags, and/or attached directly to the product and/or part. If an item is a Multi-Pack, you will see an additional Multi-Pack label and a Proposition 65 Warning on the label.
- The Bullard website (www.bullard.com) displays the California Proposition 65 on the footer of each page.
- Bullard's Build Your Bullard website (www.buildyourbullard.com) displays the California Proposition 65 warning on product ordering pages.
- All marketing literature is labeled with the California Proposition 65 warning.

To assist you with complying with California Proposition 65 regulations, please implement the following:

- If you (distributor) sell any Bullard products online, please ensure that your website contains the proper warning.

- Any catalogs used by Bullard or any distributor to sell products must also include the proper warning. (PROP65 labels are available upon request or may be ordered through our distributor portal at www.bullard.com/distributor/login)
- If a Multi-Pack package is split and sold individually it is the distributor's (or equal's) responsibility to attach the PROP65 warning label to each item in the pack. (PROP65 labels are available upon request or may be ordered through our distributor portal at www.bullard.com/distributor/login)
